



AAA-ICDR Foundation® Diversity Scholarship Fund

The fund grants diverse law students/professionals with up to \$2,000 of financial assistance towards alternative dispute resolution continuing education, training or seminar expenses. The mission of the Diversity Scholarship Fund is to encourage diversity and inclusion within the field of ADR by supporting the pursuit of knowledge and skill development through training experiences that encourage inclusive leadership growth in the field of ADR.

Eligibility

1. Member of group that has been historically underrepresented in the alternative dispute resolution profession
2. Attendance at an alternative dispute resolution continuing education, training or seminar, if the program requires you be accepted to attend you must have already been accepted
3. Need for financial assistance

Payment of Scholarship

The scholarship will support continuing education and/or training expenses within the field of ADR. If approved, a check will be made payable directly to the fund recipient.

Scholarship Application Requirements

The applicant must submit the following in a single PDF document:

1. A completed application (form below)
2. One-page cover letter of interest including details of qualifying ADR continuing education, training or seminar plus supporting program materials
3. Bio and photo to be used for announcement of scholarship awards

Review

The review process will be competitive. Not all applicants will receive award funding. Incomplete applications will not be considered. Criteria for judging will be:

1. Content and quality of application materials
2. Demonstrated interested in ADR
3. Demonstrated financial need
4. Any other relevant factors

Deadline

Applications will be accepted on a rolling basis and reviewed quarterly until appropriated funds are expended.
